These cases require specialist skills due to the complex law involved, the public interest and human rights issues at stake and the special professional demands of journalists, particularly to protect sources.

The need to protect journalistic integrity is more pressing and demanding then ever because of the growing scrutiny under which members of the press work. This is a result of the phone hacking scandal, the Leveson Inquiry and the controversial use by the authorities of their ever more extensive powers to obtain access to journalists' materials and information that may lead to the identification of sources.

We act and are very experienced in the following areas of work:

- Representing investigative journalists where undercover investigations have attracted the attention of the police, including dealing with arrests, police interviews, searches and investigations.
- Defending publishing companies and individual editors and publishers in respect of allegations of breaching court reporting restrictions, and Contempt of Court.
- Defending those accused of whistleblowing and a breach of the Official Secrets Act.
- Defending journalists covering public demonstrations and public order incidents who find themselves the target of police.
- Advising and representing journalists, media organisations and broadcasters in relation to applications by the police for production of journalistic material.
- Defending individual journalists and their sources.
